



## Energy for Tomorrow Scholarship 2025 Applicant Guidelines

Glacier Electric Cooperative sponsors, annually, 10 - \$1,000 scholarships to be used at an accredited university, college, or vocational/technical school of the student's choice. Please observe the following information and guidelines.

- The applicant's parent or legal guardian must be a member of Glacier Elective Cooperative at the time of application. **Student must live in our service territory.**
- The applicant must be a student of Cut Bank, Browning, Heart Butte, or Valier High School. Home schooled students must live in our service territory to qualify. Scholarships are available only to high school seniors.
- The applicant must have a cumulative 2.5 (C+) grade point average.
- The applicant must attend an accredited university, college, or vocational/technical school by the fall of the current year.
- **The applicant must complete the Energy for Tomorrow Scholarship application. Incomplete applications will not be eligible for consideration.**
- Applications must be received at Glacier Electric's Cut Bank office no later than **March 18th**. Applications can also be emailed to [jtatsey@glacierelectric.com](mailto:jtatsey@glacierelectric.com), with "**Energy for Tomorrow**" in the subject line.
- Selection of scholarship recipients will be based on the following percentages:
  - 50% personal statement, maximum of two page (12-point font, 1" margins)
  - 25% academic strength
  - 25% extracurricular school activities and awards/honors, community involvement, and volunteerism.
